DRAFT LEIGH PARISH COUNCIL MEETING

MINUTES of the MEETING of the LEIGH PARISH COUNCIL held on February 7th 2019, at 7:30pm at North Downs Primary School.

- 1. Apologies for absence: Mrs J Cambra, Mr R Tomkins, DCC C Osborne-Patterson, SCC H Clack, DCC Mary Huggins.
- 2. The Minutes of the Full Council Meeting held on January 4th 2019 were signed as a true record by AK.
- 3. Disclosure of Interests none declared.
- 4. Report from PCSO had not been received. The RTA at Flanchford Bridge was briefly discussed. Clerk had asked for more information regarding cause of accident. It seems that bridge has not been damaged. There had been no further information from Surrey Police surrounding the incident.

- 5. Parishioners Questions none raised at this time.

Community

- 6. Britain in Bloom entry 2019. It was agreed that Leigh should definitely enter again in April 2019. It would be good to start to involve other organisations in the village. It was noted that the crocuses on the green were a lovely addition. The Annual Parish Meeting will be a good launch platform to get other areas thinking and involved. Other local parishes had created display boards for through the year evidence.
 - 6.1. ACTION circulate feedback from last year entry, check deadline for 2019, include in Leigh Post edition. (LM)
 - 6.2. ACTION try to capture photographic material to show the breadth Leigh has to offer. (ALL)
- 7. New website is still work in progress. The text information is being worked on to be fed through to the web developers. There are a few queries outstanding including the new url format, monthly costs of hosting and a few design elements. Council is keen to make the pages as clean and easy to read as possible. Once new url has been purchased the new councillor email addresses can be organised.
 - 7.1. ACTION circulate web hosting payment options (LM)
 - 7.2. ACTION contact Monitoring officer at MVDC for requirements for url. (Can it be .org rather than .gov) (LM)
 - 7.3. ACTION continue to update text to get live asap (LM)
- 8. Plant Sale and Summer Show 2019
 - 8.1. ACTION nudge LDCGS to request permission to use land for events. (LM)
- 9. Confirm details of APM and of litter pick if available. The Surrey leade from Campaign to Protect Rural England has confirmed that he will be the guest speaker for the APM this year. It was suggested that the APM be held at the Cricket Pavilion this year rather than the school. The litterpick was briefly discussed.
 - 9.1. ACTION email invites out to guests. (LM)
 - 9.2. ACTION include information in Leigh Post edition. (LM)
 - 9.3. ACTION Request use from Leigh Cricket Club and check the pavilion is free for use. (PW)
 - 9.4. ACTION remind Mole Valley to collect the litter after the litterpick on 9th March (LM)
 - 9.5. ACTION ask The Stars if they are happy to provide refreshments (RT)

Highways

10. Stile Access to Recreation ground progress. Provisional date has been agreed with the volunteer work group courtesy of Surrey County Council. An image showing the wooden mobility access, kissing gate design being proposed. It was agreed that to provide longevity the posts that are in the ground should be made with hardwood not softwood. All other elements could be softwood. It was discussed and accepted that this would increase the cost. The posts would need to be circa 7ft and there would need to be hardcore provided.

- 10.1. ACTION order the gate from approved supplier and liaise with volunteer group to get installation (LM).
- 11. Bend at Ashurst Farm continues to be problematic and dangerous. Norwood Hill Residents Association had lobbied Surrey Highways to improve the soft surface at the edge of the road. There has been sand added to build up the sides but this has already got lorry tracks in it. In an ideal scenario the roadside would be widened by up to 6ft to the hedge next to the farm.
 - 11.1. ACTION respond to Surrey Highways highlighting it is an accident hotspot and needs more (LM)
 - 11.2. ACTION check with PCSO Reid if there is any accident data on that bend available (LM)

Amenities

- 12. Allotments LDCGS have requested a plot to be used for relaunching their childrens gardening club. There had already been a site meeting. They requested that the first-year rent be waived in light of the charity status. They would like permission to put on a shed and ultimately a polytunnel. All present happily agreed and felt that as a charitable set up the annual rent should be waived indefinitely. ALL AGREED
 - ME referred to the work still required on the corner of Newdigate and Bunce Common Rd. The current hedge needs to be removed, the ditches dug and joined. He is time pressured at present but it is still WIP. AK mentioned that she suspects that the pipe underneath the entrance is blocked and needs clearing. ME agreed to look at it.
 - 12.1. ACTION arrange allotment lease for plot 3a for LDCGS (LM)
- 13. Review Playground inspection report. Unfortunately, RT was unable to attend. AK felt that looking at the inspection report, anything with a medium or high risk should be addressed.
 - 13.1. ACTION put together an action plan for discussion at next meeting (RT)
- 14. Harrington Close boundary. LM had pushed back to Clarion stating that the work sat on their land and therefore their responsibility. It was agreed that to access any of the tree work there was a huge number of brambles needing cleared possibly by a working party. These clippings would generate a huge volume of waste that could potentially be burnt. The PC could then lobby Clarion to action the tree-work needed.
 - 14.1. ACTION assess the site on the Green side of Harrington Close (ME).
- 15. Noticeboard replacement signage was agreed. To be domed including Leigh Parish Council, coloured green and A4 x 8 in size. SA raised the state of the one on Dean Oak Lane. It was agreed that a smaller domed noticeboard be purchased for that site rather than repairing it. The board access also is incredibly muddy on DOL, the option of stepping stone path was discussed.
 - 15.1. ACTION arrange purchase of the two noticeboards (LM)
 - 15.2. ACTION request quote for installation from Handyman and to make improvements to the access path up to the board (LM)

Planning

- 16. Horsehill drill site application deadline for objections is 18th Feb. AK summarised the application for those present. 4 new well sites, 1x water well, extraction for another 25 years, vertical and horizontal wells. Making it the 2nd largest onshore drill site in the UK. Other objections had been submitted by: Salford & Sidlow PC, Charlwood & Hookwood PC, Horley Town Council, Norwood Hill Residents Association, Horsehill Action Group. Many of these objection letters had been circulated and all were available to view. The other factors to be aware of were 8 diesel generators installation, generating 140 tonnes. The methane and excess flaring pollution. The last week had seen two additional earthquakes. There was great concern regarding the horizontal drilling and the relationship with the drilling. The level of monitoring was of concern. There are to be up to 32 taker movements every day. What happens if the current road system needs diverting? Will that affect Leigh in the future? What about storage on site is it safe? The 2015 application stated conventional drilling, now they want horizontal drilling. The consultation had involved the following consultees: Betchworth PC, S&SPC, C&H PC and Horley Town. Leigh had not been included despite bordering the land. It was agreed that Leigh would object on the following grounds: Traffic, Flaring and noise pollution.
 - 16.1. ACTION write and objection letter to SCC (AK)
- **17.** New Gate activity update from LDCGS. The contractors were expected to start looking at the site but no work would take place until after the toad crossing season finishes, end of April. (AK)
- 18. Future Mole Valley update. Added in briefly as part of Bimonthly Clerks Meeting update in January. Guy Davies (Planning) had been queried by LM on the following:

Boundary changes. Are these to allow backfilling in the future. Some villages will be able to do this but as Leigh is washed over the Metropolitan Greenbelt this would not be the case. The changes are to follow best practice in terms of redrawing settlement boundaries as having been advised.

We have been informed that the landowners have been encouraged to pursue their plots being considered by surveys and other outgoings. Is this across the board? Yes- these landowners have submitted their land and so this would naturally be the next step for consideration. All landowners have had the same communication. The Parish Clerks were informed that an initial proposal would be consulted on after the May elections now. (LM)
