## DRAFT LEIGH PARISH COUNCIL MINUTES

MINUTES of the FULL COUNCIL MEETING of the LEIGH PARISH COUNCIL held on 16<sup>th</sup> November 2020, at 7:30pm. This meeting was held remotely in accordance with the Covid-19 Pandemic restrictions. The meeting was not recorded.

Present Cllrs: Mrs J Cambra (Chair), Mr P Wilkinson (Vice Chair), Mr S Ames and Mr R Tomkins.

Also, present: Mrs L Mann (Clerk), Mr R Worth (Footpath Officer).

### Parishioners: 2

- 1. Apologies for absence: Cllr Mr M Everitt, SCC Cllr H Clack and DCC Cllr Huggins apologies were noted.
- 2. **The Minutes of the Full Council Meeting** held on **October 19**<sup>th</sup> were acknowledged as a true record by JC to be signed in person at a later date.
- 3. Disclosure of Interests. None declared.
- 4. Crime Report from PCSO. Very little to note. (Appendix A)
- 5. Parishioners Questions.
  - **5.1.** Resident asked if there would be improvements made to the corner hedge at the allotments on Newdigate Road. Clerk was sure that whips had been purchased and needed planting.
    - **5.1.1.** ACTION check with Ms Kinloch regarding the whips. (LM)
- 6. Clerk Report/Matters Arising
  - **6.1.** Action points that were resolved and outstanding were noted (Appendix B)
  - **6.2.** Correspondence to note. On 19<sup>th</sup> October, Leigh Parish Council had received a letter of concern regarding the use of funds to set up the community Apple Press. Due to the seriousness of the matter they had met at a meeting on November 10<sup>th</sup> to discuss. Cllr Ames and Wilkinson were not included in the meeting as they have an interest. The full council noted that the committee considered the facts and came to the conclusion that there had been no impropriety.

### Community

- 7. **Footpath Officer's report (RW)** Drivers using the Glebe to park have been driving over the corner of the grass on the green resulting in it being churned up. RW has positioned two traffic cones to dissuade car users for driving on it. It was suggested that this was people parking for the school.
- 8. **Covid-19 support update (JC)** There has been communication to date via Facebook, Leigh Post, noticeboards. There has been a number of calls made to the volunteers this week. The volunteers remain on standby should demand increase. It was noted that the village hall has been completely closed to hirers except the nursery (Leigh Lollipops) until 3<sup>rd</sup> December.
- 9. **Community Projects/grants.** There have been no requests for more information or applications regarding this as of yet.

### Highways and Service

- 10. **Highway work/issues.** Residents highlighted that there were issues with the hedges on Newdigate Road. She had logged her request with Surrey Highways but as yet had not had a response. She felt that the hedge needed clipping as drivers were often in the middle of the road going around the corners. It was mentioned that Rose Bungalow on Dean Oak Lane appeared to be installing an access driveway to a garage at the back of their garden. This would lead to pulling out directly onto Smallshill Road.

### **Amenities**

- 11. **Playground Update (RT).** Two main points were noted: 1. The toddler bridge had now been repaired. The safety fence and pins have been removed. 2. Mr Barry Springer has very kindly agreed to make the metal staves for the totem pole gazebo free of charge. They just need to be made and installed. Cllr Cambra thanked Robin Worth and Tim Stevens for their work in getting the toddler element functioning again.

- 12. **Tree Work Phase 1,2.** Work has been completed, and the invoice was being raised. The next phase would require tendering and planning. There was a substantial number of crown cleans required over the next 6-

12months. It was noted that the old oak between the village hall and Sweet Briars would be being removed soon due to it being rotten.

### **Planning**

- 14. Applications Registrations, decisions, appeals (Appendix C) The only application this meeting was for the St Barts plans MO/2020/1033. The application had been approved with conditions at the Building Committee meeting. The Parish Council had submitted a letter outlining concerns regarding the project to the church (Dean and Diocese) copying in the planning case officer. The questions and concerns had been noted by both. These points had also been included in the MVDC case officers report. It was suggested that the Parish Council draw resident attention to the effort made regarding the application. The Parish Council letter of representation was available for all to view on the planning portal.
- 15. **Leigh Cricket Club.** The CC were considering their options now that they have received three quotes. It had been requested that the Cricket club receive a 50% discount on their annual rent due to their reduced income from loss of games, income stream from bar takings at the fireworks and Leigh Show and hiring out to school rentals due to Covid-19. The rent is balanced by money they spend on improving the facilities (including the pavilion).

- 16. Payments (Appendix D) were noted for the month.
- 17. Balance Sheet Q2, 2020 (Appendix E) and Bank Statements Q2, 2020 were noted by the Council
- **18.** To Confirm the Finance Committee Meeting Minutes (Appendix 1). Councillors had struggled to open document. Clerk to resend for approval at December meeting.

### **District and County Updates**

19. SCC Cllr Clack had kindly provided an update in her absence. She is arranging a meeting for all of Dorking Rural parish councils to discuss 'Your Fund' and hope we will be able to agree a date shortly. She also covered flooding issues and active travel buds.
