LEIGH PARISH COUNCIL MINUTES

MINUTES of the FULL COUNCIL MEETING of the LEIGH PARISH COUNCIL held on 20th September 2021, at 7:30pm.

- 135. Apology for absence had been received and accepted from MVDC Cllr Mrs M Huggins.
- 136. The Minutes of the Full Council Meeting held on 19th July 2021 were acknowledged as an accurate record and signed by JC.
- 137. Disclosure of Interest. None declared.
- 138. Parishioners Questions
 - 138.1. Parking JB reported that the classes in the afternoons are unable to park in the Village Hall due to people parking to use the playground. She requested that the lower driveway gate to the pavilion be opened to allow playground users to park there. There could be security issues, but it could be trialled.
 - 138.1.1. ACTION as a trial leave the gate open until the weather turns wetter. Inform and check with the Cricket Club that this is not an issue. (PW/LM)
 - 138.2. Length of perimeter grass remains long. It has been cut but not to low levels in previous years. The LCC had been approached regarding this and had felt it be left for rewilding areas. They will be recutting it once more at the end of the season.
 - 138.2.1. ACTION contact them to recommend they revisit the length being left (PW/LM)
- 139. Crime Report (Appendix A) had been circulated. Includes up to the beginning of August. Additional points:
 - 139.1. A couple on Tapners Road had found someone walk into their kitchen. Police notified. It was hoped that it was a genuine error and nothing sinister (notified via the community Facebook page.)
 - 139.2. There had been round bales set fire to over the weekend (notified via the community Facebook page.)

- 140. Clerk Report/Matters Arising (Appendix B)
 - 140.1. Correspondence over July to Aug
 - 140.1.1. Query regarding approaching cows in fields. Have contacted the row team for guidance on etiquette etc. There had been a separate incident in Newdigate where an elderly lady had been trapped with her dog. PW recommended circulating the information available on the Ramblers website regarding walking near livestock. There are Legal requirements, and a countryside code exists.
 - 140.1.1.1. ACTION circulate via the usual communication channels to inform residents the best way to approach livestock when walking particularly with dogs. (LM)
 - 140.1.2. Garden waste bins. There is to be no collection for those who pay for the service due to HGV driver shortages. LM mentioned there is a possible private supplier operating in local parishes. Costs would be around £12 per collection.
 - 140.2. Wicket Covers. Three covers will be purchased, and each can have branding on them. Leigh CC have asked if LPC object to them having sponsorship on two. PW recommended this be approved assuming that the sponsorship as suitable (no alcohol, betting, or smoking etc).
 - 140.2.1. RESOLVED: The PC approved in principle to the Cricket Club having sponsorship on the wicket covers. The final brand would need to be approved by Leigh Parish Council.

140.2.2. Remembrance Sunday. – clerk asked if there are enough lamp post poppies for this year.

140.2.2.1. ACTION - request 10 more if available from MVDC. (LM)

- 140.3. Leigh in Bloom. Continue to celebrate the Silver Gilt award this year. Jean Griffin entered on behalf of the PC this year. Jean Griffin will be present at the LDCGS food festival and apple press. She will present the Silver Gilt certificate for 2021 to the Council on the day.
- 141. Community Projects and Grants
 - 141.1.1. Leigh History Publication -AK updated the Council. Posters have been circulated to show how to buy them! Sold 38 copies to date. The money going into a separate account for transparency. AK is awaiting for the invoice for the printing costs. These will then be covered by the Parish Council.

- 142. Litter pick Saturday 2nd October. Collect on the Sunday. ME kindly offered to collect the bags on the Sunday and put them on the layby.
 - 142.1. ACTION: arrange collections and check if any items needed from MVDC depot (LM)
- 143. Leigh Apple Press and Food festival Saturday 25th September. Noted. Highways and Services
- 144. Highways
 - 144.1. Newdigate Rd speed survey has been approved. The cost is £240. Surrey Highways have recommended holding off submitting the purchase order until spring 2022 as they won't action the request until then.
 - 144.2. It was noted that there has been recent traffic monitoring on Tapners Road, just past Gadbrook Rd.
 - 144.2.1. ACTION try and find out what the action is for and if the results are available (LM).
- 145. Flooding
 - 145.1. RT had contacted Surrey Highways regarding the outstanding/overdue drain/ditch clearing in the area. There has been no response to date. Contacts may have left. (RT)
 - 145.2. It was noted that there was activity at the Pump Station on Smallshill Road today. There has been recent drain works carried out by a private contractor.
 - 145.2.1. ACTION submit FOI to Thames Water regarding recent monitoring activity. (LM) Amenities
- 146. Playground
 - 146.1. The new seesaw has been vandalised and still needs addressing. RT believes it can be repaired. Depending on the excess it may not be worth doing via the insurers.
 - 146.1.1. ACTION Log crime report. Ask insurers regarding excess. Order replacement parts (LM/RT)
 - 146.2. Your Fund: RT is currently working towards the application to be submitted for the grant. He is awaiting a quote from a third supplier for the fort replacement.
- 147. Allotments
 - 147.1.1. ACTION JC and LM to address recent suggestions and improvements.
- 148. Green spaces
 - 148.1. The next Phase of Tree work was now due. The quote had been circulated. LM had offered up options in terms of budget with the work to be prioritised and split over this year and 2022/23.
 - 148.2. <u>It was noted that the Memorial bench location has been informally approved</u>. The family have orderd a 5ft bench. It will go next to another bench on the West side of the Green with the back to the Harrington Rd hedge line where the gap in the hedge is.
 - 148.3. Stiles on Recreation ground. There is one old stile near Newdigate Rd (Leigh PC responsibility) and one new access point on Bunce Common Rd (LM is chasing for SCC members fund and SCC funding- no response yet). A new kissing gate would allow walkers to get off the road

- verge easily rather than them walking down it to the existing gate on the corner opposite the village hall. It was noted that currently the old sile near Newdigate Rd gets removed completely for the Leigh Flower Show.
- 148.4. Gateway on Bunce Common Rd. RW had recommended we remove the old gate and hedge the stretch. A quote had been circulated for the works. The Parish Councillors wanted to explore whether they could do this voluntarily instead.

149. Planning

- 149.1. Applications Registrations, decisions, appeals (Appendix C)
 - 149.1.1. Application MO/2021/1509 was briefly discussed regarding future change of use but it was felt that from an objective planning perspective the application could not be challenged. No action.
- 149.2. Gatwick Expansion Public Consultation is now open closes 1st December. GAL invited parish councillors to join a briefing with members of the project team. There would be an initial presentation on the proposals which would then be followed by a Q&A discussion. The meeting would be held via Zoom in the evening of September 28th. GAAC are also happy to come and answer any questions.
 - 149.2.1. ACTION- circulate briefing information and request details regarding traffic specifically. (LM)
- 149.3. MVDC local plan has been re circulated. No major changes for Leigh sites (Tapners Rd and Priest House). There has been slight reduction in numbers. There were implications for other villages though! (For example, the Hookwood housing proposal has increased)
- 150. Administration & Finance
 - 150.1. Payments for authorisation were noted (Appendix D)
 - 150.2. Receipts were noted (Appendix E)
 - 150.3. The conclusion of AGAR 2020-21 was noted. This was concluded by the external auditors with no comments to note. PW and JC thanked the clerk for her work on this.
- 151. Upcoming Meetings and dates to note (Appendix E)
- 152. Parishioner's Questions Comments
 - 152.1. Local plan consultation. Can we look to have a FMV specific meeting. More specific areas, to consider for Leigh. What needs to be addressed. Managing expectations. Create a specific meeting.
 - 152.2. Community Infrastructure Levy money (around £5700) how this will be used? Possibility to use towards traffic calming. Potential to ask residents regarding how to spend the money. It was noted that there are controls on how we can spend the money.
 - 152.3. Moon Hall School have now got 8 minibuses. It was felt this was a positive move, removed additional car journeys off the road.
 - 152.4. Village Hall. There had been issues regarding underpinning and the subsequent window issues. Out the front the tarmac has been cut short. MVDC grant had been gratefully received and was helping with funding the new windows etc.
 - 152.5. <u>Clerk requested the Dawes Green Layby be strimmed as it is very overgrown. APPROVED</u>
