DRAFT LEIGH PARISH COUNCIL MINUTES

MINUTES of the FULL COUNCIL MEETING of the LEIGH PARISH COUNCIL held on 21st March 2022 at 7:30pm at The Pavilion, Leigh Recreation Ground.

- 253. **Apologies for absence** had been received and accepted from Cllrs Mr R Tomkins, Mr S Ames, SCC Cllr H Clack and DC Cllr M Huggins.
- 254. **The Minutes of the Full Council Meeting** held on 21st February 2022. PW raised an amendment to item nets (the proposed number is 4 not 2 as stated). This change was made and then the minutes were acknowledged as an accurate record and signed by JC.
- 255. **Disclosure of Interests** if any and any changes to Register of Interests. None declared.
- 256. **Parishioners Questions**. None at this time.
- 257. Clerk Report/Matters Arising were noted (Appendix B)
 - 257.1. Action Point status was noted.
 - 257.2. Correspondence summary was noted. It was agreed that this would be a good addition to the meetings in the future.

Community

- 258. **Litter pick** JC raised her thanks to the local volunteers who attended in March. She stated that there had been lots of litter still despite there being a litter pick only in January.
- 259. **Community Projects and Grants**. There had been no new applications received at this time.
- 260. Queen's Jubilee. The next meeting from the community group was set for the Wednesday 21st March at 7:30pm. Cllr Wilkinson would be attending to represent the Parish Council. The committee was being run by a local resident.
- 261. **Leigh in Bloom 2022**. Mrs Jean Griffin had been provided with supporting information for the Parish submission, by the clerk. The judging date was still to be confirmed but was expected to be in June/July.
- 262. The Annual Parish Meeting was confirmed to be on the evening of May 12th. LM requested suggestions for a guest speaker. A few suggestions were made.
 - 262.1. ACTION Enquire regarding availability for guest speakers (LM). <u>Highways and Services</u>

263. Highways.

- 263.1. ACTION Request speed survey be booked in on Newdigate Rd now it is the right time of year (LM).
- 264. **Flooding.** Nothing new at this time.

Amenities

- 265. **Playground.** There had been a kind donation of wood preservative for the rustic wood equipment in the playground. It was agreed that this would be best completed by a professional as getting volunteers proved tricky.
- 266. **Allotments.** There was no update.

267. Green spaces

267.1. SCC Tree grant. (The free hedge whips and saplings received through a Surrey CC intiative). ME had kindly arranged for his team to plant them on the corner of the allotment. He noted that they are very small in size and would take a while to become established. On inspection, the old gate site on BCR has hardcore underneath it. The gate will need moving to remove the hardcore. It

- was suggested that they consider popping in fence posts and enclosing the area. This is to be explored.
- 267.2. Recreation Grass on the cricket boundary. A resident has raised concern around the length of the grass on the outer boundary of the recreation ground. The real issue being that it ends up with dog waste in it. The Parish Council agreed that this was a problem. Currently the PC contractors do not cut any grass on the recreation ground, only within the playground. The Cricket club maintain the field and currently do not go as far out as the hedge.
 - 267.2.1. ACTION contact the cricket club for their ability to cut the boundary regularly.

 Does not need to be cut as close as the green but it should be taken up to the hedge. PW would check the lease regarding the Cricket Clubs responsibilities.
- 267.3. Kissing Gate Cllr Foulsham requested that the project to allow access to the recreation ground directly opposite the footpath on the north side of the rec be made as soon as possible.
 - 267.3.1. ACTION parts need to be quoted for. A working party would be needed to install with the posts.
- 267.4. Tree schedule. It was noted that the final phase of tree maintenance was due to start in early April. Payment will be made in April.

Planning

- 268. The Parish Council considered the applications registrations, decisions, appeals (Appendix C). The following observations were made:
 - 268.1. MO/2022/0352 It was felt there was lack of clarity on the application. There was concern regarding the change of use of the land. They are putting it on land with nothing on it. They have said 'no' to change in use. It is not a residential dwelling? Office and gym currently. It is inappropriate and can be seen from the road. LM to submit to concerns to the MVDC Planning.
 - 268.2. MO/2021/2150 No objection was made regarding the current application, however there was concern regarding the extension of the brick wall and the lighting. LM to enquire as to whether they needed to address the brightness of the lighting.

Administration & Finance

- 269. The Council noted and approved **the payments** (Appendix D). Payments were not able to be raised at that time due to limited signatories present.
- 270. The council noted the bank **receipts** (Appendix E)
- 271. To approve risk register. This would be sent by email to Cllr Wilkinson for annual approval. (PW)

- 273. Parishioner's Questions
 - 273.1. Log complaints regarding the overgrown hedge on the Old School House. The hedge still encroaches onto the pavement posing a hazard to pedestrians.
 - 273.1.1. ACTION Log onto the Surrey Highways portal.
 - 273.2. RW had cleaned the fingerpost sign on the green. He noted that there is paint missing on the arm where posters have been stuck on.
 - 273.2.1. ACTION: LM to enquire from the maker as to the best way to repair it.
